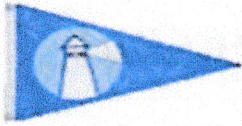

I hereby apply for membership in the Nantasket Beach SaltWater Club. I have received a copy of the Rules and By-Laws, which I shall read and agree to abide by if I am accepted into the Club. A non refundable initiation Fee of \$50.00 (fifty dollars) shall be submitted with this application.

Candidates for membership must be over twenty one (21) years of age and sponsored by a member who is not on probation and who is in good standing. Upon receipt of the initiation fee by a Club officer, the membership shall be notified of the candidate's application in a newsletter to the membership. The **candidate** and the **sponsor** shall appear at the next membership meeting. If the proposed member cannot make the General Meeting the sponsor shall appear and bring a full page photograph of the proposed member and advocate on their behalf. After the candidate is introduced he or she will be asked to step outside whereupon a hand vote will be taken. If there are any no votes cast then the candidate's membership shall be referred to the EBoard which on the same evening shall hold an Executive Session. Any member may address the EBoard in the Executive Session on the merits of the candidate's admission. If referred to the EBoard, the candidate's admission to the Club requires a two thirds (2/3) vote of approval of the EBoard members voting by secret ballot.

Upon receiving election to membership the new member shall pay the annual dues and begin a **1 (one) year probation period**. Any conduct detrimental to the good and welfare of the Club, including but not limited to, vandalism, or theft of Club or member's property will result in immediate termination of the Club membership and forfeit of monies paid.

The annual dues amount is set by the Board and is **due before April 1st** each year. If dues are not paid by May 1st, the member is assessed an additional 25% of the annual dues and is considered an inactive member, without Club privileges. **If dues, late fees, or fines are not paid by June 1**, in full, the member shall be removed from the membership roll of the Club and is subject to initiation fees and dues before reinstatement.

As a member, I further agree to serve on one or more club committees and to **perform a minimum of 20 (twenty) Work Hours annually**. I further understand that I will be given an assessment of \$30.00 (thirty dollars) per hour for any hours not worked. The hours must be completed or the assessment paid by June 1st to be considered a member in good standing. **There will be no applications accepted after October 1st.**
